A Letter from the President...

End of the year Thanksgivings!

This newsletter takes us through the holidays and into the New Year. The year passed quickly and brought with it much excitement along with some solemn occasions. We will always want to remember those we lost as we continue to celebrate our time together. Many thanks to our wonderful volunteers who continue to help through times of recovery and who help execute the festive events. It is the efforts that we put forth to take care of each other as a community that continues to make Cheshire Forest a wonderful place to live.

The excitement of 2017 has kept the Board busy in several areas. One of the most pressing is the re write of our governing documents. We worked with the Chesapeake Bay Management (CBM), our community managing agency, to conduct the mailout of the rewritten and restated bylaws for each resident to review and be prepared to cast their vote. Based on the numerous emails sent to several Board members and the extensive remarks posted on the different social media sites, the Board is moving the date of the vote to JANUARY 16, 2018 during the regularly scheduled monthly Board meeting.

This allows time to make some changes based on the feedback the Board is receiving and to conduct another mailout. CBM has agreed to cover the cost of this mailout and we thank them for doing this for us. Residents also can attend meetings in November and December to ask any additional questions. We had a good forum with many residents present in October when we covered several pressing concerns. You may have read Julie's post regarding the changes but I'll include here:

Architectural Control Committee - We are reverting the text back to that in current documents, which will hold the ACC to the 30 days 5.7

Right of Way – We are also reverting this back to verbiage in current documents We also heard that some individuals in the association did not receive their packets. We researched and found that this was due to a corrupted address file in the firm hired to send them. The board has agreed that we will be making the changes above and then resending the entire documents (including the proxy) again to the whole association. Once that document is sent, we will also post to Facebook and Nextdoor that they will mailed so homeowners can be on the lookout for them in the mail. To allow for everyone to have time to review the documents, we have moved the voting date to January 16, 2018. We will also be having board meetings on November 21st and December 19th and would welcome homeowners with any questions or concerns to attend at 7pm.

Look for your new packet in the mail along with a proxy should you not be able to attend the meeting to vote in January.

That action is in January, however, please plan to attend our **ANNUAL MEETING on 21 NOVEMBER 2017**. It is our regular scheduled 3rd Tuesday of the month time frame and for those of you not yet beginning Thanksgiving celebrations I hope you can come by the clubhouse. We will discuss the state of the association, the execution of our 2017 budget and the newly adopted 2018 budget. We also have at a minimum three Directors to fill.

We are always looking for exciting individuals who would like to volunteer. Please contact the management if you are interested. Following the election process and the business of the annual meeting, we will elect Board officials. The future is unknown but what is known is that I have enjoyed serving as the President and working closely with the group of professional volunteers who help keep our community a great place to live.

Remember if you are not able to attend the Annual Meeting on 21 NOVEMBER please complete and send your proxy. Hope to see all there.

Changes to How You Schedule a Bulk Trash Collection




We're happy to provide bulk trash collection as part of your Chesapeake Waste Management service and now, we want to make the process of scheduling that collection even easier. We've taken out the question of whether your collection is household or yard/tree debris. Now you just schedule a bulk trash collection! If you're like me and love to schedule these collections online through www.CityofChesapeake.net/Requests, especially since you can do that up until 11:59 p.m. the day before your trash day, then this will make that process even faster. You'll select "Bulk Trash Collection" and then you'll choose what item needs collected (e.g. mattress, appliance, tree limbs, bushes, etc.).

Keep in mind, though, that just because we're combining the scheduling process does not mean we want you to combine your piles at the curb. You may remember from my article a few weeks ago that we can dispose of vegetative waste at a much cheaper price than all other garbage so be sure to keep those piles separate. Vegetative yard waste

should always go in a separate pile. Fence posts and lumber do not count as yard or vegetative waste.

All other size and limitations rules for bulk collection still apply. You're allowed only one 4' wide x 4' high x 6' long pile of vegetative waste per week. Household waste is limited to only one 4' wide x 4' high x 10' long pile per week with a maximum of 12 collections per calendar year. For more rules and restrictions, visit www. On numerous occasions, the CPD has emphasized the importance of reporting crime/suspicious activity. Without proper reporting, the CPD is at a loss to adjust assets to cover those affected areas.



To report, the non-emergency number is 382-6161, and you can also file a report on-line using the Citizen's On-Line Reporting System. To access the on-line system, google City of Chesapeake, then go to Police

Department, and you will find the on-line reporting system. Only specific activities can be reported on-line, and those are listed. Thanks, and until next time, BE SAFE!


