#### **BOARD OF DIRECTOR'S NOTES**

The Board conducted their regularly scheduled Board of Director meetings on May 19th, and June 16th. The April 21st meeting was cancelled due to COVID 19 gathering restrictions. Your Board remains focused on maintaining the material condition of neighborhood's assets, responsibly managing your neighborhood's financial resources, and upholding our neighborhood's standards. Specifically, the Board has tried to provide creative recommendations to committees and management to follow the Governor's phased restrictions and opening the community assets for use. The following list highlights some of the Board of Directors actions.

#### **Recently Completed Actions:**

- Contracted the replacement of the 3-rail fence at the main entrance
- Contracted for the removal of fallen trees
- Revised Architectural Control Committee Guidelines
- Amended the Pool Contract with High Sierra Pools due to COVID
- Contracted for a new Reserve Study to be conducted 1st Qtr of 2021

#### **On-Going and Future Actions:**

- Obtaining estimates to resolve Clubhouse drainage issues
- Obtaining estimates for repair/replacement of club house deck/gazebo
- Working to open the pool for use to all within Virginia Governor's phased restrictions

More detail concerning these issues and actions can be found in the Board of Directors Meeting Minutes which are published monthly. All residents are cordially invited to attend the Monthly Board Meetings (third Tuesday of each month) and participate in the Homeowners Forum. The Homeowners Forum provides residents insights into upcoming events, actions taken by the Board of Directors, but most importantly provides you an opportunity to voice suggestions or concerns with the Board. Most recently, the Homeowners forum has been used to address concerns regarding restrictions of community assets due to COVID-19.

We are always looking for volunteers who can help make a difference in our neighborhood. Positions are open in several of the committees. Please consider stepping forward to help keep Cheshire Forest the envy of Great Bridge and "The best community in Hampton Roads!"

#### LETTER FROM THE PRESIDENT

#### Changing Times...

What an interesting time in which we live! The COVID-19 situation reaches all – from the national level, state level, county level, city level, COMMUNITY level, and at the individual level. Each person must decide how to respond to the mass amount of information that is shared daily regarding the virus. These actions in many ways correspond to how the different levels of governing bodies are responding. Cheshire Forest is also reacting to and in many areas, developing methods to respond to our new environment.

The Board of Directors, the volunteers leading our multiple committees, the HOA management agency, and many individual volunteers are working to develop processes that will potentially enable our community to use Cheshire Forest's wonderful amenities again. There are challenges that we must overcome as we continue this journey. These challenges range from developing a responsive understanding of the CDC guidelines to dealing with contract issues presented by vendors who are also developing methods to respond to changes. The methods we are enduring often come at an unbudgeted price. And, as we live in a litigious society, many have concerns about liabilities, real or perceived, regarding proposed approaches. Discussions that may potentially lead to an understanding and agreement regarding procedures and processes as we strive to open our facilities take time. Some situations may require changes to the vendors currently in use. All actions are worked by community volunteers and all have ideas, and all are keeping the best interest of our community in mind.

As I often do when preparing comments for the newsletter, I review input from past years. I reflect on my submission for the summer of 2018 that included an article discussing what is necessary for a community to have a "great board." The following paragraph is very appropriate for our current situation:

"Great boards know that liabilities are a risk to the HOA and to themselves, and always face that risk head-on by dealing with potential and evident liabilities quickly and surely, according to their set policy. Great boards understand, and never shy away from, risk management. They obtain information and direction from insurance, legal and management experts to guide them on the safest path, which starts with a heads-up approach to running the HOA."

The Board we have today along with many wonderful volunteers continue working to guide our community into uncharted waters and are meeting many risks head-on. Cheshire Forest volunteers are freely donating time and mental efforts to address risks and overcome obstacles to develop methods to approach our new environment. A few of these wonderful volunteers include Tracy Tucker, swim team representative; Randi Corcoran, social committee

chairperson; and Jim and Mary Burres, pool committee chairs. These people are developing or have developed acceptable ways to keep Cheshire Forest a wonderful place to live. The graduation parade organized for our community, the food trucks at the clubhouse, and the bike parade celebrating our Nation's wonderful freedom, are examples of what volunteers are doing within our community. Randi, our social committee chairperson, has led the efforts on these social events and continues to do a wonderful job. Tracy has led the development of methods that will assist the Cheshire Forest Flying Fish (our community's swim team) to have a 2020 season and will it ever be different! Jim and Mary along with two wonderful volunteers, Chris Bowers and Natalie O'Conner, are developing procedures designed to address CDC guidelines as we work to open our pool to enjoy remaining time the summer days offer. Board volunteers are giving much effort to address contract issues that impact the opening of the pool and our clubhouse. It is often frustrating and it may feel like the community is doing nothing especially after a long, hot, day in the house enjoying spouses, children and siblings; however, many volunteers are doing wonderful things to keep our community strong.

As Virginia continues to work the phased approach to the current pandemic, our community works to address methods to operate within the changing conditions. Some methods come with an additional price, some are moving at a pace that one may not agree with, but all methods include thoughts that keep the best interests of our community up front.

In closing I recall a recent conversation with a potential new resident. As I sat in my garage enjoying the heat and humidity that only Virginia can offer, the potential buyers stopped to ask me about the community. I easily told them stories about the wonderful things our community offers, and from where I sit, our clubhouse and its surrounding amenities are easily observed. I discussed the initiatives of our social committee, the swim team opportunities, tennis, and many other things. I then had to reflect on why I was able to have such a positive conversation with this family. It is because of the wonderful volunteers serving and because of the many wonderful people who live in our community. Thank you for your understanding that as we continue to navigate in our changing environment, many volunteers are working to overcome obstacles and challenges. The pace may not be as quick as we desire, but nevertheless, the efforts continue.



# Neighborhood Watch Corner: Neighborhood Awareness/Reporting

Cheshire Forest is an active family neighborhood, with many residents out and about, and we want to keep it that way! Neighborhood Watch Block Captains keep an eye out for suspicious activity, but as there are only 23 Block Captains, the more eyes/ears, the better. We ask that all residents do their part and be aware of what is happening around us. Chances are if you see

something that doesn't look right, it probably isn't right.

In May we had our front entrance sign and signage on Sheffield Rd vandalized (painted). It was reported to a Block Captain, and CPD was called. CPD responded, filed a report, and even had the forensics unit capture photos to ensure it was not gang related (which it was not). The cleanup/paint removal was done by four of our board members.

The CPD has told us on many occasions, if something looks suspicious, call the CPD and let them do the investigative work. Non-emergency number is 382-6161.


