Hello and Happy Fall! My name is Jennifer Williams. For those of you I haven't had the opportunity to speak with yet, I am the Association Manager for Cheshire Forest.

Clubhouse Area-Young people loitering at the clubhouse: Over the past few months a considerable amount of trash left behind, and damage has been noticed to the Association property. Unfortunately, it appears this is the work of young people who may be from our community as well as surrounding developments. Chesapeake Police have been authorized by the Association to stop and detain anyone found loitering in the Common Areas around the clubhouse so parents, please speak with your young adults about this serious matter.

Lawns-The weather is also cooling off. Now is the time to give your yards a little extra TLC (also known as WFO – weed, feed and over-seed). Please don't forget to attack the weeds that grow between the asphalt and the curb in front of your home. Keeping the weeds clear at the street and curb line really improves our curb appeal.

BOARD OF DIRECTOR'S NOTES

The Board conducted their regularly scheduled Board of Director meetings on July 21st, and Aug 18th. The Sep 15th Board meeting was cancelled due to board member availability. The September Board meeting did occur the following Tuesday, on Sept 22nd. Your Board remains focused on maintaining the material condition of the neighborhood's assets, responsibly managing your neighborhood's financial resources, and upholding our neighborhood's standards. The following list highlights some of the Board of Directors actions.

Recently Completed Actions:

- Rolled over (2) CDs that matured on July 23rd
- Contracted the removal of fallen trees from a Tropical Storm
- Conducted Property Management Company interviews and analysis
- Had detailed discussions on Security Cameras for the Club House that included Chesapeake Police Department
- Approved the 2021 Pool Contract
- Negotiated the 2021 Landscaping Contract
- Began the negotiations to enter into a new Property Management Contract with United Property Associates

On-Going and Future Actions:

- Preparations for the November 17th Annual Board meeting
- Electing or re-electing (2) Board Members
- Addressing Homeowner concerns with Geese and Security around the club house
- Continuing to follow all COVID regulations while still remaining a social and neighborly community

More detail concerning these issues and actions can be found in the Board of Directors Meeting Minutes which are published monthly. All residents are cordially invited to attend the Monthly Board Meetings (third Tuesday of each month) and participate in the Homeowners Forum. The Homeowners Forum provides residents an opportunity to voice suggestions or concerns with the Board.

Neighborhood Watch Corner: Neighborhood Engagement

Over the last several months, there have been issues with young people hanging out around the clubhouse area. We know many of you are aware of this issue as we see comments on Facebook and Nextdoor. What should be noted is that not all the young people are causing trouble, some are just meeting friends there or hanging out. If the young people are respectful

and not causing damage, all is good, but when there is foul language, littering, taunting younger kids, vandalism, etc., that is where the issues begin.

Neighborhood Watch has been/remains in communication with the Chesapeake Police Department on these and other situations. Vandalism reports on damages around the clubhouse area have been filed with the CPD. Neighborhood Watch does not patrol the neighborhood so we would ask that if any resident sees anything illegal or suspicious, please call the CPD non-emergency number at 757-382-6161, or 911 if an emergency. Increased neighborhood engagement will only assist in reporting issues as the issues take place. There have been residents that

have reported suspicious/illegal activities, and to them we say Thank You!
