#### **BOARD OF DIRECTOR'S NOTES**

The Board conducted their regularly scheduled Board of Director meetings on April 20th, May 18th, and June 15th. The next monthly board meeting will occur on July 20th. In addition, the Board held a Special Board Meeting on June 8th to review the Security Committee's Recommendations Report. Your Board remains focused on maintaining the material condition of neighborhood's assets, responsibly managing your neighborhood's financial resources, and upholding our neighborhood's standards. Specifically, the Board has tried to provide creative recommendations to committees and management to follow the Governor's phased restrictions and opening the community assets for use. The following list highlights some of the Board of Directors actions.

#### **Recently Completed Actions:**

- Contracted the trimming of the trees at the Parker Road/ Sheffield Drive entrance and other common area locations

- Contracted for the pressure washing of the pool deck, gazebo, pool building, and pool fence

- Worked to open the pool for use to all within Governor's phased restrictions

- Worked on a near daily basis with AAA Pools to ensure maximum pool services available for the community

- Approved the posting of monthly board meeting open session agendas on Cheshireforest.org

- Established the Communications Committee and an initial 4 topics to address from the Special Security Committee Report, one of those tasks is in partnership with the newly named Neighborhood Watch / Security Committee.

- Reinvested (3) CDs

**On-Going and Future Actions:** 

- Recommending revisions of the ACC Guidelines to address basketball goals

- Begin upgrades of the Club House FIOS services and hardware

More detail concerning these issues and actions can be found in the Board of Directors Meeting Minutes which are published monthly. All residents are cordially invited to attend the Monthly Board Meetings (third Tuesday of each month) and participate in the Homeowners Forum. The Homeowners Forum provides residents insights into upcoming events, actions taken by the Board of Directors, but most importantly provides you an opportunity to voice suggestions or concerns with the Board.

We are always looking for volunteers who can help make a difference in our neighborhood. Positions are open in several of the committees. Please consider stepping forward to help keep Cheshire Forest the envy of Great Bridge and *"The best community in Hampton Roads!"*

#### LETTER FROM THE PRESIDENT

This summer brings us the normal warmer weather, but one bonus this year is the reduced restrictions that we endured last year. It is great to see the young people heading to the pool in the mornings for swim team practice, it is great to see so many residents using the pool, and it is great to see so many residents out and about throughout the neighborhood.

Speaking of the pool, our pool management company is still hiring lifeguards and luckily for us, have been able to staff our pool on most days. We have had a few days of closure, and we may have a few more, but lifeguard manning levels have greatly improved from the projection made just a few short weeks ago. Management and the Board still maintain close coordination with the pool company. Our goal is to have the pool open every day and will do what we can to ensure that happens. We will still post any scheduled pool closings on our website, Nextdoor, and Facebook.

I want to give a big "Thanks" to the Security Committee for their efforts in putting together a recommendations report for the Board of Directors. As most know, we formed a Security Committee a few months back to review security issues and make recommendations to the Board. That recommendations report was the subject of a special board meeting on 8 June. During that meeting, there were discussions on how to best accomplish some of the recommendations. Ultimately, the decision was made to form a new committee, the Communications Committee, that will focus on how best to engage the neighborhood via online communications/social media. We also renamed the Neighborhood Watch committee to the Neighborhood Watch/Security committee. This committee will focus specifically on those security items addressed in the report to include security cameras and lighting. Once these two committees coordinate proposals, those proposals will be reviewed by the board for implementation.

As I mentioned the swim team earlier, I must applaud the Flying Fish team efforts this year! After an abbreviated and virtual season last year, it is great to see the team back in action this year. Tracy Tucker has been our Swim Team lead for a few years now, and I think everyone knows that is not an easy task. Thanks Tracy! Thanks also to the many parents who volunteer to assist Tracy in ensuring the Swim Team have a fun and rewarding season!

One last note, for those of you wondering what I can do for the neighborhood, I would please ask that you consider volunteering for one of our committees or to assist with a neighborhood event. If it were not for the volunteers in the neighborhood, most of the activities/ events we host would not be possible. 
In February the Cheshire Forest Security Committee was formed to explore ways to deal with security concerns and illegal activity around the common areas. Officer Jason Saburn, our Community Resource Police Officer, came to one of our first meetings. He advised, as always, if you see anything suspicious that you feel is not an emergency you may call 757-382-6161 (non-emergency police number) and of course 911 for immediate response. We met with Officer Everette, of the Chesapeake Crime Prevention Unit for a security review of the common areas around the clubhouse. Her top recommendations are cameras and good lighting. The Neighborhood Watch and Security Committee are now joined together and are currently focused on trying to get cameras installed on the outside of the clubhouse.

National Night out is August 3, 7 PM at the clubhouse. Come learn about crime prevention, meet some of our police officers and enjoy ice cream, followed by a flashlight walk!
