MANAGER'S CORNER

It was great to see everyone out and enjoying the pool and other community activities and amenities this past summer.

With that in mind, I just want to pop in a few notes and reminders:

- School is back in session, and we have lots of young folks at the bus stops so please drive safely, the posted speed limits are enforced by the Chesapeake Police.
- All exterior alterations must receive prior approval from the Architectural Control Committee before any work begins. If you need an application, please email me at jkohlman@unitedpropertyassociates.com. They can also be downloaded from the community website (www.cheshireforest.org)
- **Please do not start a project without approval**
- •As always, pick up after your pet and respect other people's property.

The Architectural Committee has approved the following change regarding basketball goals: Permanent basketball goals are prohibited unless approved by the ACC and shall at all times be kept neat, clean and maintained in a good state of repair. Portable basketball goals are permitted and shall be kept neat, clean and maintained in a good state of repair. Basketball goals shall be a product that is commercially produced and purchased for use. Homemade goals are strictly prohibited. Both

permanent and portable basketball goals are to be placed/situated on the homeowners' lot no less than 50% of the way up the driveway from the street to ensure the safety of those at play. Both permanent and portable basketball goals shall be anchored and stabilized consistent with the manufacturer's guidelines. The anchoring and/or stabilizing of basketball goals with cinder blocks, rocks, concrete bags or the like, is strictly prohibited.

The manager is usually on property the first three Tuesdays of each month. If you need to pick up or drop something off to the manager, the best hours are from 1-4pm. The manager does inspections and meets with vendors in the morning time frame.

The 2021 Annual Meeting is scheduled for *Tuesday, November 16*. This meeting is a perfect opportunity to address the board on any concern you may have. Additionally, there are several open board positions that will need to be filled. If you are interested in serving on the board, please fill out the board interest form that will be included in the Annual Meeting package and send back to the manager. This package is scheduled to be in the mail in late October.


