BOARD OF DIRECTOR'S NOTES

The Board did not hold the regularly scheduled meeting in July as a quorum was not established due to Board member availability. The Board conducted their regularly scheduled Board of Director meetings on August 16th and September 20th. The next monthly board meeting will occur on October 18th. Your Board remains focused on maintaining the material condition of the neighborhood's assets, responsibly managing your neighborhood's financial resources, and upholding our neighborhood's standards.

Recently Completed Actions:

- Clubhouse security camera installation and policy development
- Voted to approve My Green Condo as the future neighborhood Content Management System (CMS). The CMS will be active as soon as possible
 - Contracted pool winter maintenance
- Accepted contractors proposal to repair/replace clubhouse deck railing
- Reviewed/discussed the neighborhood landscaping contract
 - Developed the 2023 budget

On-Going and Future Actions:

- Neighborhood signage update
- Neighborhood trashcan replacement

More detail concerning these issues and actions can be found in the Board of Directors Meeting Minutes which are published monthly. All residents are cordially invited to attend the Monthly Board Meetings (third Tuesday of each month) and participate in the Homeowners Forum. The Homeowners Forum provides residents insights into upcoming events, actions taken by the Board of Directors, but most importantly provides you an opportunity to voice suggestions or concerns with the Board.


