- The deposit or a portion thereof will not be refunded if there is damage or loss to the facilities. If such damage, repairs, or replacement exceeds the deposit, said user shall be responsible for any and all additional costs.
- 3. The homeowners signing this agreement shall be present at all times during the period that the pool is reserved and agrees, in the case of a private pool party, to end the event by 10:00 PM on the rental date and have all guests off the premises no later than 10:15 PM.
- 4. Homeowner recognizes that this rental agreement applies to the pool only and does not include access to the clubhouse or deck.
- 5. Homeowner shall ensure all trash is collected into plastic bags and placed in the trash containers in the pool area. If there is no room in the trash cans, your trash must be removed from the premises.
- 6. Food, drink, and/or personal items left over from your function should either be discarded or taken with you when you leave. The area should be left in a reasonably clean condition and neat manner and there should be no visible evidence that your function has taken place.
- 7. The homeowner reserving this facility shall hold harmless the Association for any bodily injuries or property damage that may arise from the homeowner's use of the facilities.
- 8. The homeowner reserving these facilities agrees that the said use of these facilities shall be made in full compliance with the communities posted pool rules, all laws, statues, and ordinances of the Commonwealth of Virginia and the City of Chesapeake.
